Project Overview

Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

Purulia is a backward rural and poor area of West Bengal, India. Rotary Club of Purulia is working in the field of Eye Care as savior since its inception in the year 1968 in this region with a motto of "Service Above Self". The club has dedicated a Multi Speciality hospital to the community on 17th December 2017. The hospital has been equipped with modern equipments. The club wants to add an Immunoassay machine and a portable ECHO machine to its diagnostic unit.

The immunoassay machine will help the people of Purulia to get faster result of their different thyroid tests for which they now have to wait for 3-4 days. This will help them to get the advantage of early treatment. It may sometime be also used in treating patients suffering from eye problems.

An echo machine is vital equipment used to perform an echocardiogram - an ultrasound examination of the heart. A new portable echo machine will enable more patients to be treated at their bedside.

An upgraded Phacoemulsification machine will add support to the ophthalmology unit. This machine will help the ophthalmologists to operate cataract surgeries in a better way and help the patients in early recovery.
