

TERMS & CONDITIONS

(Approved by RCS Youth Service Committee v022021)

Introduction

1. Rotary Club of Singapore is conducting an online short video award competition known as “**Rotary Youth Community Service Award**” for Singapore schools.
2. Participation for the award is subject to the following terms and conditions (the Rules). By entering the competition, you agree to be bound by these Rules.
3. Contestants for the Rotary Youth Community Service Award register online by completing the entry form found under: <https://rotary.org.sg/page/youth-community-service-award>

Eligibility

The contest is open to all Singapore schools (secondary and JCs). A special category for Interact Clubs is also opened.

Submission Guidelines

1. The theme of the Rotary Youth Community Service Award addresses “**The Impacts of Covid-19 Pandemic on Children in ASEAN**”.
2. Entrants shall explore the theme in context by engaging with an overseas beneficiary in ASEAN in an original, witty way.
3. Work must be the contestant’s own original material.
4. The contestant must complete the online entry form on the Rotary Club of Singapore Website which requires registering the contact details and the video title. Entries submitted without an online application will be disqualified.
5. By uploading the **video link and a report** outlining pre-, onsite and post-delivery activities via the online entry form, the contestant grants the organizer a perpetual, non-exclusive and payment-free license globally to:
 - a) Reproduce, use and exploit the intellectual property, to the full extent permitted by intellectual property law in any jurisdiction
 - b) Reproduce, adapt, edit and publish the video in any associated promotional material, posters, advertising etc. including the Rotary Club of Singapore website, without limitation.
6. In the event that an award winner is subsequently found in breach of the terms and conditions of entry, their work may be ruled invalid and the award deemed null and void. In that case the entrant must return the prize received.
7. Rotary Club of Singapore reserves the right at all times to determine whether an entry qualifies is suitable for consideration. Rude, defamatory, insensitive, racist or offensive material will be disqualified and will not appear on the website. The decision of what is considered rude and/or offensive material will be at the discretion of the judging panel and competition organisers.
8. All submissions will be shortlisted and judged on their creativity and how effectively they communicate their message.
9. Deadline for submission is **30th June 2021 - 11:59pm SGT**. Any videos submitted after the deadline will be disqualified.

Judging Panel & Prizes

1. All submissions will be shortlisted and evaluated by a judging panel by their creativity and how effectively they communicate their message.
2. The Judging Panel will consist of min five members appointed from Youth Service Committee of the Rotary Club of Singapore
3. The Judging Panel's decision is final, and no correspondence will be entered relating to the judging process or the outcome.
4. All winners will be announced via email during the **1st week of August 2021** and the top 3 winners will be invited to a Rotary Club of Singapore event in September 2021 to receive the award plaques
5. All winners will also receive a merit certificate from the Rotary Club of Singapore.

Indemnity

1. The Rotary Club of Singapore and its respective officers, employees and members have no liability for any costs, losses or damages of any kind, which you may incur, arising whether directly or indirectly. This applies in relation to or in connection with any material and/or information supplied by the contestant in connection with the competition; and as a consequence of removing any material and/or information from the competition.
2. The contestant will at all times indemnify and keep indemnified Rotary Club of Singapore and its respective officers, employees and members (in this paragraph referred to as "those indemnified") from and against any loss (including reasonable legal costs and expenses) or liability incurred by any of those indemnified arising from any claim, demand, suit, action or proceeding by any person against any of those indemnified where such loss or liability arose out of, in connection with or in respect of any breach of these terms and conditions by the contestant; and publication of or distribution of the material and/or information supplied by the contestant.

These terms and conditions may be amended, deleted or added to from time to time at the discretion of the competition organisers. Any revised terms and conditions will be informed via email in a timely manner. By uploading and submitting the video link via the online entry form, the contestant agrees to the full terms and conditions – **so please read them carefully.**
